This elite society was established in 1921 during World War I to control the political and financial life of the U.S. Their ultimate goal is to annihilate national boundaries to bring all independent nations into a world government.

We would like to take some time to discuss one of the world's most wealthiest, famous, and influential families in the world who has made a major impact on the conquests of secret societies and American culture: The Rockefeller Family.

Patriarch of the Rockefeller Family, John Davison Rockefeller (1874-1960) and founder of Standard Oil (now Exxon Mobile), helped finance the CFR and World War I. His eldest son, John D. Rockefeller (1906-1978) was a member of the CFR and sat on the Board of Directors of Princeton University. In 1918, he founded the Foreign Policy Association <http://www.fpa.org>, a non-profit organization committed to informing the public on global issues. He also founded the Institute of Pacific Relations (IPR) in 1925 whose mission embraces former President Woodrow Wilson's *Internationalism* ideology (world government/economy philosophy).

In addition to John D's previous exploits, he established the Asia Society in 1956 geared towards cultivating understanding and cooperation between Americans and Asians (<http://www.asiasociety.org>). We believe the IPR and Asia Society were forerunners of the Trilateral Commission (to be discussed) in view of the fact that the Rockefeller Family is highly favorable of one-world government.

Not to be forgotten, David Rockefeller (1915-) is the last surviving son of his father, graduate of Harvard University, former officer of Chase Manhattan Bank, original member of the Bilderbergers, and Honorary Chairman of the CFR and Trilateral Commission. He steered his political, academic, and business endeavors by Fabian Socialism—a British intellectual doctrine that teaches gradual changes result in the reshaping of a society’s core political and economical framework. Please see the below quote from David’s 2002 book entitled *Memoirs*:

For more than a century, ideological extremists at either end of the political spectrum have seized upon well-publicized incidents to attack the Rockefeller family for the inordinate influence they claim we wield over American political and economic institutions. Some even believe we (the Rockefeller family) are part of a secret cabal working against the best interests of the United States, characterizing my family and me as ‘internationalists’ and of conspiring with others around the world to build a more integrated global political and economic structure—one world, if you will. If that’s the charge, I stand guilty, and I am proud of it. (Rockefeller, 2002, p. 405)

Let’s sum up the matter: Rear Admiral Chester Ward, former member of the CFR for 16 years, forewarned the U.S. citizens in 1975: “The most powerful clique in these elitist groups have one objective in common—they want to bring about the surrender of the sovereignty of the national independence of the United States. A second clique of international members in the CFR comprises the Wall Street international bankers and their key agents. Primarily, they want the world banking monopoly from whatever power ends up in the control of global government.” (Melvin Sickler, *Thirst for Justice*)

Trilateral Commission

David Rockefeller and Zbigniew Brzezinski, former National Security Advisor for Jimmy Carter, joined forces to establish this globalist group in 1973. Although the CFR had members from key sectors, Rockefeller felt that a multi-national aristocracy needed to be formed in order to accelerate the plans for one-world government. So, he adjoined 300 of the most influential leaders in government, military, and business from the three major geographical areas of the world: The U.S. (including Canada), Western Europe, and Japan. Their mission <http://www.trilateral.org> is to seize control of the military, political, and economical affairs of the countries within their geographical sphere. In order to conquer a people, one must control the (1) economical, (2) political, (3) and military affairs of that nation.

At the present, *Western Europe (European Union)* has absorbed 27 countries, with several others currently joining. The EU has one prime currency—the euro. *Japan* has seized government control over, South Korea, Australia, and New Zealand, the People’s Republic of China, Hong Kong, Taiwan, and the ASEAN nations (Indonesia, Malaysia, Philippines, Singapore, and Thailand). The *United States* is also keeping their part of the deal. Effective 2010 (some sources say 2012), the United States, Mexico, and Canada will merge into one supra-nation, called the *North American Union*. We will also have one currency called *Amero*. The Bush Administration was secretly working towards this goal (for this reason former President George W. Bush never successfully secured the U.S. borders to stop illegal immigrants—this was never part of the plan). The Obama Administration is currently taking measures towards the NAU.

The nucleus of the TC’s plan envelops the progression of the global economy, or [globalization](#) intended to centralize and advance the wealth of the world’s elite. Their goal is to destroy the rights and liberties bestowed by our Constitution, and all maneuvers towards this mark is financed by international bankers, like the Rockefellers and the Rothschilds.

Bilderbergers

The Bilderbergers is perhaps the most secretive of all societies and is referred to as the *High Priest*. This *communist* society has created global policies for years.

Their first meeting was held in May 1954 at Hotel de Bilderberg in Oosterbeek, Holland to establish plans for a unified Europe and a new world order. Their meetings are held yearly, top-secret and are by invitation only--all members and attendees are sworn to secrecy. The Bilderbergers plan wars, finances them, and ends them; control economies world-wide, making decisions on interest rates, gas prices, and more (Chairman of the Federal Reserve Bank, Ben Bernanke is a member). The Bilderbergers place presidents and leaders in key positions, and decide what we will and will not hear through the media and news. The CEO’s of our major news networks and newspapers are members, as well as many popular, highly paid journalists.

The Bilderbergers have been known to spend hundreds of thousands of dollars on security by positioning military forces to guard the surrounding areas of their meeting places, luxury hotels and resorts around the world. If any uninvited guest crosses the invisible security lines, he or she is gunned down—top secret.

Please read the following quote by David Rockefeller during a Bilderbergers meeting in 1991:

We are grateful to The Washington Post, The New York Times, Time Magazine and other great publications whose directors have attended our meetings and respected their promises of discretion for almost forty years. It would have been impossible for us to develop our plan for the world if we had been subject to the bright lights of publicity during those years. But the world is now more sophisticated and prepared to march towards a world government. (Faria, 2001)

As we can see, there is a consortium of the CFR, Trilateral Commission, and the Bilderbergers. President Barak Obama is a member of the CFR and has close connections to the Bilderbergers having attended their June 2008 meeting held in Chantilly, VA. Senator John McCain is also a member of the CFR. Former President George W. Bush (and Daddy Bush) is a member of the Trilateral Commission and the Bilderbergers, while Condoleezza Rice is a member of the CFR. Either way it goes, no matter which president is in office, steps towards a one-world order will be facilitated. What a monopoly!

And concerning the *war on terror*, these societies understand that citizens love the sovereignty of their nations, and the only way to move everyone into a one-world mentality is through fear. Former President George H.W. Bush exclaimed, “From chaos will emerge the New World Order” (Jeffrey, 2000, p. 29).

During a Bilderbergers meeting in 1992, Henry Kissinger, former Assistant for National Security Affairs under President Richard Nixon (1969-1974) and Secretary of State under President Gerald Ford (1974-1977), spoke these words:

Today Americans would be outraged if UN troops entered Los Angeles to restore order; tomorrow they will be grateful! This is especially true if they were told there was an outside threat from beyond, whether real or promulgated, that threatened our very existence. It is then that all people of the world will plead with world leaders to deliver them from this evil. The one thing every man fears is the unknown. When presented with this scenario, individual rights will be willingly relinquished for the guarantee of their well being granted to them by their world government.
